What to do now

If you are claiming Constant Attendance Allowance because of an accident, please read leaflet **SD7** *Disabled because of an accident at work* before making your claim.

If you are claiming Constant Attendance Allowance because you are suffering from a prescribed disease (other than an asbestos related disease), please read leaflet **SD6** *ill or disabled because of a disease or deafness caused by work* before making your claim.

If you are claiming Constant Attendance Allowance because you are suffering from an asbestos related disease, please read leaflet **SD8** *ill or disabled because of working with asbestos in your job* before making your claim.

You can get these leaflets from your social security office.

■ How we collect and use information
